### WELCOME

Social responsibility is an integral part of a successful and sustainable business. At Bell Gully, we remain firmly committed to working alongside charitable organisations and the community to help those in need. In this issue of *A Helping Hand*, we highlight some of our efforts, and profile the work of a selection of our pro bono clients.

# WHAT

Bell Gully's pro bono programme is focused on contributing what we do best - our legal expertise. Over the past year, we've continued our support of long-standing pro bono clients, and added some new ones. We're thrilled that we have reached our \$1 million fee equivalent target, and that our efforts were recognised at the ALB Australasian Law Awards, where we received the award for 2012 Corporate Citizen Firm of the Year.

### LEGAL ADVICE

We provide free and discounted legal advice to a wide range of charitable organisations, some of which are showcased in this publication. We have also helped a number of individuals to achieve access to justice.

Our efforts have enabled our pro bono clients to direct funds that would otherwise be paid in legal fees towards their organisation's specialty areas.

Getting involved has given our lawyers exposure to new areas of law and the opportunity to contribute for the better of our local communities.

We're nurturing long-term relationships, confident in the knowledge that when we do pro bono work, it has a far-reaching impact.

### **COMMUNITY LAW CENTRES**

A significant proportion of our pro bono resource is focussed on supporting local community law centres (CLCs), which provide legal services to those who can't afford to pay for them.

We have established partnerships with three local community law centres:

- Grey Lynn Neighbourhood Law Office (Auckland)
- Waitakere Community Law Service (Auckland)
- Community Law Wellington and Hutt Valley (Wellington).

Among other services, we provide a secondee lawyer to each of their offices for one day every week, mentors for junior lawyers, and volunteer lawyers for evening clinics.

This support has not only provided the CLCs with much needed resourcing, it has also helped broaden the expertise and experience of the in-house CLC lawyers, as well as that of our secondee solicitors.

### **BUSINESS SUPPORT**

Over the last two years we've extended our pro bono assistance to include the involvement of our non-lawyers. Our business support teams contribute to our pro bono and community efforts through provision of information services, information technology expertise, marketing and communications advice, and secretarial support.

# WHO

Our pro bono clients work tirelessly with sometimes limited resources to help individuals and communities in New Zealand and internationally. It's no easy task, so any support or involvement is always welcome. We asked four of our pro bono clients to share with us the work that they do, the challenges they face, and some of the results they have achieved.

Leukaemia & Blood Cancer New Zealand (LBC) is the leading organisation in New Zealand dedicated to supporting patients and their families living with blood cancers such as leukaemia, lymphoma, myeloma and related blood conditions.

LBC provides a comprehensive range of services, which include personalised support programmes for patients and their families through regular visits and contact, as well as a toll free number and an online forum. These not only provide empathy and support, but also practical advice, financial assistance and the opportunity to talk to others who have been through similar experiences.

In addition to patient and community support, LBC has contributed \$3 million towards research into blood cancers and related blood conditions.

LBC also helps to develop public awareness and understanding,

by supplying vital information to patients and families, health professionals and the wider community, as well as through various campaigns and fundraising events. Key initiatives include World Lymphoma Awareness Day, Blood Cancer Awareness Week, Shave for a Cure, the Firefighters Sky Tower Stair Challenge, the Corporate Sky Tower Stair Challenge, SKYCITY Dining for a Difference, and the Golf Marrowthon events.

It currently costs LBC around \$3,000 a day to run its support services programme, ensuring expert help for patients and their families is at the end of the phone or available in person. In order to keep growing and running their services free of charge, LBC is constantly challenged to develop its fundraising models to provide year-on-year growth.

As LBC receives no government funding, it relies entirely on the support of individuals, corporate sponsors, community groups, trusts and fundraising events. Since 1977, the generosity and support of these sponsors has allowed LBC to help patients and their families throughout the journey – from diagnosis, to treatment, to recovery.

Bell Gully has offered pro bono and community support to LBC for over eight years, having been involved in events such as Dining for a Difference, Shave for a Cure, Golf Marrowthon and the Skytower climb, amongst others, and by providing pro bono legal advice.

The Parenting Place began in 1993 with Ian and Mary Grant's dream to equip and encourage New Zealand parents, delivering their message with an inspiring and entertaining voice. It aims to positively impact every family, and to give New Zealand parents the skills and resources they need to raise their children as best they can.

Now, 20 years later, the dream has gone from strength to strength, with CEO Bruce Pilbrow heading an organisation that reaches hundreds of thousands of families each year. The Parenting Place is committed to giving families and young people positive and practical help, by providing affordable courses and resources to ensure full accessibility. It also provides further subsidies for those who need them. To support this work, The Parenting Place relies on sponsorships and donations, and remains grateful to all its supporters who have ensured the sustainability of the organisation.

The Parenting Place passionately believes that Family is Everything, serving families through a wide range of programmes – Toolbox parenting groups, Hot Tips for communities, Hot Tips for businesses, Fathers' Breakfasts, The Parenting Show with Pio, Pasifika Families, Parenting Magazine, Family Coaches, the centre in Auckland, Attitude Programmes for Schools, and events for emerging leaders.

As society evolves, The Parenting Place has altered its programmes and resources to stay relevant, recently extending support to foster carers, and to grandparents raising their grandchildren.

Bell Gully has supported The Parenting Place for many years now, providing legal advice on a wide range of issues on a pro bono basis.

### GF CARES

The bread donation programme run by Goodman Fielder since 2006 sees the donation of around 180,000 loaves of bread annually to food banks throughout New Zealand. The company celebrated the launch of The Goodman Fielder Cares Trust by the delivery of the one millionth loaf to the Auckland City Mission.

GF Cares will continue to donate fresh loaves to food banks and City Missions, but also gives employees at its 17 sites the chance to get involved in a volunteering programme, or to donate some of their earnings to the Trust. Donations by employees will be matched dollar for dollar by the company, to a capped amount annually.

The GF Cares Trust is run and managed by employees of Goodman Fielder. Through the support of the company, the Trust is able to ensure that 100% of all donations received supports its initiatives.

GF Cares is setting out to make a real difference to Kiwis in need and any support provided is greatly appreciated by families who face poverty on a daily basis.

There will be numerous ways for employees, customers and suppliers to get involved with GF Cares. Currently its main focus is to drive interest and awareness in the Trust within Goodman Fielder. To do this, they are working with sites throughout the country to set up activities, including local volunteering and fundraising initiatives.

Bell Gully was pleased to assist in the formation and settling of the Trust, including the Trust Deed, as well as organising and managing the Trust's application process for charitable status with the Charities Commission.

The GF Cares Trust was launched in March 2013, and aims to help people and organisations in need through the donation of food and resources. The Trust is supported by Goodman Fielder NZ Ltd and its employees, as well as customers and suppliers, through a variety of initiatives including a work place giving programme, and a community service scheme. It is underpinned by a bread donation programme.

# Some of the recipients of the Red Cross Christchurch Schoolchildren's Grant, launched in February 2013.

### RED

Since the September 2010 and February 2011 Canterbury earthquakes, New Zealand Red Cross has been committed to standing by the people of Canterbury as they recover from one of the worst disasters New Zealand has faced.

The New Zealand Red Cross
Earthquake Appeals raised
\$128 million in donations, with
100 per cent of every public
donation in New Zealand going
towards people affected by the
Canterbury earthquakes. To date,
the New Zealand Red Cross 2011
Earthquake Commission has
distributed \$83 million in grants to
more than 97,000 people. It has
also organised more than 6,480
outreach visits, 5,164 door knocks,
and co-ordinated support groups
and events for bereaved families.

The New Zealand Red Cross recovery programme has won two major international awards for its work in Canterbury. The first is the Partners in Preparedness award for the torch radio outreach programme, which saw 43,454

torch radios and emergency preparedness information packs distributed to school children, the elderly, people with disabilities, migrants and refugees. The second is the Public Awareness Award for the recovery communications programme, which alerted people in Canterbury to help they could still receive from Red Cross.

Last year, Bell Gully provided pro bono legal advice to New Zealand Red Cross in connection with programmes supporting individuals affected by the Christchurch earthquakes. These included the NZ\$9.3 million Christchurch Schoolchildren's Grant and advice in connection with a weekend retreat to support bereaved families.

One of the challenges that Red Cross and other community organisations face is that, as recovery efforts move into a third year, the energy, resilience and optimism throughout the Christchurch community are slowly being replaced by frustration. To help, New Zealand Red Cross recently brought out psychologist and disaster specialist Dr Rob Gordon to talk to community groups and those working in community development on how to work through this and other challenges.



Our commitment to social responsibility is demonstrated not only through our investment in the pro bono programme, but also through our individual actions at work and in the wider community. Bell Gully is involved in, and invited to, many events spanning sport, culture and the arts. ### Leukaemia & Blood Cancer

LBC and Bell Gully have a long history, which has seen us take part in many Shave for a Cure and Dine with a Difference events, and the Golf Marrowthon 100 Hole Challenges. We extended our involvement in 2013, by having our summer clerks help to promote the Shave for a Cure event into other corporate organisations across Auckland.

### **First Foundation**

First Foundation provides support to students from low decile schools by setting up multi-party mentoring relationships between students, schools, and businesses. Each year, Bell Gully supports a First Foundation scholar with paid work experience, a financial scholarship to assist with education costs, and a personal mentor arranged through First Foundation.

### Taita College

Taita College students benefit each year from a group of junior Bell Gully lawyers who volunteer their time to provide guidance and advice. The mentoring programme aims to increase the students' self-confidence and to encourage them to achieve their full potential. It also gives the students a role-model who is interested in them and in their development - often providing a different perspective on things.

We support these charitable endeavours because we believe in their vision and because we see the direct benefit to our people as well as those involved with the organisations themselves. As a firm and as individuals, we get so much more out of these activities than we give, and we're grateful for that opportunity.
